Comparators for the January 2019 monthly financial statements are based on the 2018-19 Mid-Year Economic and Fiscal Outlook (MYEFO) published in December 2018.

#### FISCAL OUTCOMES

## **Underlying Cash Balance**

The underlying cash balance for the financial year to 31 January 2019 was a deficit of \$21,856 million, which is \$2,955 million lower than the 2018-19 MYEFO profile deficit of \$24.811 million.

## Receipts

Total receipts were \$128 million higher than the 2018-19 MYEFO profile.

#### Payments

Total payments were \$2,892 million lower than the 2018-19 MYEFO profile.

## **Net Operating Balance**

The net operating balance for the year to 31 January 2019 was a deficit of \$11,807 million, which is \$3,424 million better than the 2018-19 MYEFO profile deficit of \$15,231 million. The difference primarily results from higher than expected revenue and lower expenses.

#### **Fiscal Balance**

The fiscal balance for the year to 31 January 2019 was a deficit of \$13,625 million, which is \$3,634 million better than the 2018-19 MYEFO profile deficit of \$17,260 million. As with the net operating balance, the difference primarily results from higher than expected revenue, lower expenses and lower net capital investments.

#### **Assets and Liabilities**

As at 31 January 2019:

- net worth is negative \$446,748 million;
- net debt is \$373,417 million; and
- net financial liabilities are \$652,528 million.

#### NOTES:

#### **Australian Accounting Standard 1049**

The Australian Government monthly financial statements have been prepared on a basis consistent with the Budget as required under section 47 of the *Public Governance, Performance and Accountability Act 2013*. The statements are prepared in accordance with the Australian Accounting Standards Board 1049 – *Whole of Government and General Government Sector Financial Reporting* (AASB 1049), which require treatment based on the Australian Bureau of Statistics' (ABS) Government Finance Statistics (GFS) except where Australian Accounting Standards (AAS) provide a better conceptual treatment for specific items. Departures are limited to complying with either ABS GFS or AAS.

#### Taxation revenue

While total tax collections are known with certainty at the end of each month, the distribution across the relevant heads of revenue cannot be finalised until all business activity statements are received and processed. The outcomes for some revenue items provided in this statement are therefore estimates, in accordance with the best judgement of the Commissioner of Taxation, and subject to revision. The taxation revenue items not affected are: petroleum resource rent tax, excise duty, customs duty, other taxes and individuals refunds.

## **Style conventions**

Figures in tables and generally in the text have been rounded. Discrepancies in tables between totals and sums of components are due to rounding.

#### **International Monetary Fund Special Data Dissemination Standards**

The Government is committed to releasing the monthly financial statements in a timely fashion and will endeavour to do so in accordance with International Monetary Fund (IMF) Special Data Dissemination Standards (SDDS). Under these standards the timeframe for releasing the monthly financial statements is by the end of the following month. Australia applies a special flexibility option which allows it to publish late the last and first month of a financial year.
