Note: Machinery of Government changes had occurred on 20 December 2017, which has changed the name for a number of portfolios:

- Immigration and Border Protection has been renamed 'Home Affairs';
- Infrastructure and Regional Development has been renamed 'Infrastructure, Regional Development and Cities';
- The Employment and Industry, Innovation and Science Portfolios have been amalgamated to create the 'Jobs and Innovation' Portfolio; and
- Human Services has become its own Portfolio, separating from Social Services
