Material entities are required to produce more detailed financial information than non-material entities, for the purposes of providing monthly, end-of-year and estimates reports to the Department of Finance. All Departments of State, Public Financial Corporations and, Public Non-financial Corporations are classified as material.



- Statutory Agency (recorded against some bodies in the far right hand column) means the agency is identified in its enabling legislation as a Statutory Agency for the purposes of the *Public Service Act 1999*, whereby the legislation provides for the Agency Head to employ APS employees for that Agency.
- Executive Agency (recorded against some entities in the far right hand column) means the agency has been made an Executive Agency, through an Order made by the Governor-General, under subsection 65(1) of the Public Service Act 1999, whereby the Agency Head employe APS employees for that Agency.
