#### Dear President

I write with regard to Senate Order 23E Commonwealth Grants Rules and Guidelines, agreed by the Senate on 12 May 2020.

The Senate Order requires that I lay on the table by 30 April of each calendar year:

- (a) all reports and correspondence received by the Minister for Finance under paragraph 4.12 of the Commonwealth Grants Rules and Guidelines 2017 during the preceding calendar year (noting that the Guidelines do not apply to all grant administrators, including not applying to the allocation of funding by Sports Australia under the Community Sport Infrastructure Grants program ('Sports Rorts')); and
- (b) a summary of the decisions reported under paragraph 4.12 of the Commonwealth Grant Rules and Guidelines 2017, including the Central Budget Management System program title, sub-program, grant activity, grantee, total grant value, grant funding location, postcode, and a brief statement of reason for the decision.

Paragraph 4.12 of the *Commonwealth Grants Rules and Guidelines 2017* (CGRGs) requires ministers to report to the Minister for Finance annually on all instances where they have decided to approve a particular grant which the relevant official has recommended be rejected. Ministers must report by 31 March each year for the preceding calendar year.

Consistent with the intention of the Senate order and with the reports that I provided last year, I have interpreted "correspondence received … during the preceding calendar year" to mean correspondence related to the preceding year. If the order were read literally, then the current report to the Senate would cover grants awarded in 2020 rather than 2021. I suggest that the Senate might consider revising the language in the order accordingly, to better reflect what was intended.

In accordance with the Order, I enclose a copy of a letter dated 16 February 2022 from Senator the Hon Michaelia Cash, Attorney-General and Minister for Industrial Relations, reporting two instances of decisions during the 2021 calendar year and a subsequent supplementary letter dated 7 April 2022 correcting a typographical error (Attachments A and A.1). The grant recipients have been omitted due to obligations under the *Privacy Act 1988* (including Privacy Principle 6 relating to the use and disclosure of personal information) and the content of the relevant Commonwealth Guidelines.

I also enclose a copy of three letters, each reporting one instance, dated:

- 8 March 2022 from the Hon David Littleproud MP, Minister for Agriculture and Northern Australia (Attachment B);
- 10 March 2022 from the Hon Keith Pitt MP, Minister for Resources and Water (<u>Attachment C</u>); and
- 29 March 2022 from Senator the Hon Richard Colbeck, Minister for Senior Australians and Aged Care Services and Minister for Sport (<u>Attachment D</u>).

A summary of the decisions reported under paragraph 4.12 of the CGRGs for the 2021 calendar year is provided at <u>Attachment E</u>.

I refer to the reporting requirements under paragraph 4.12 of the *Commonwealth Grants Rules* and *Guidelines 2017* (CGRGs).

I advise that records of the Agriculture, Water and the Environment Portfolio show that there was an instance during the period 1 January 2021 to 31 December 2021 where I, as Minister for Resources and Water, approved a grant for Water function that the Department of Agriculture, Water and the Environment recommended not be approved, details of which are enclosed.

For the related grant round, I sought additional information regarding seven applications including the actual applications. For the application in question, it was clear that the proposal would achieve improved water quality and invasive pest remediation consistent with the selection criteria. The Assessment Panel considered the level of detail provided was insufficient to make a sound assessment, which one may expect from individual farmers who are not accustomed to seeking such grants.

This grant was not located within my electorate of Hinkler, Queensland.
