# **Pathways to Procurement Program**

## Nomination/Application Toolkit

Managers of suitable candidates or interested officials themselves may submit an application for the Pathways to Procurement (PtP) Program.

## OVERVIEW

The Pathways to Procurement (PtP) program is an initiative designed to enhance procurement and contract management capabilities within the Australian Public Service (APS). It aims to establish a structured and sustainable pathway that supports APS officials who are new to procurement and contract management roles, enabling them to quickly build the necessary skills and knowledge to effectively carry out their responsibilities. The most suitable candidates for the PtP program are APS officials who are either transitioning into PCM roles or have been in PCM roles for less than 12 months and hold a position at a Commonwealth entity that is subject to the CPRs.

The program incorporates procurement and contract management training modules developed and delivered by Finance, a Certificate IV in Procurement and Contracting delivered by a Registered Training Organisation, and additional professional content.

## FINAL SELECTION OF PARTICIPANTS

Finance will select candidates from nominations/applications received to participate in the PtP program. Successful candidates and their supervisors will be informed via email.

## NOMINATION/APPLICATION GUIDELINES

To ensure candidates and entities receive the maximum benefit from participating in the pilot PtP program, we recommend that managers submitting a nomination or officials applying themselves consider the following:

- Is the candidate transitioning into a PCM role or have they been in a PCM role for less than 12 months.
- What specific skills and knowledge do you expect the candidate to acquire from completing the PtP program?
- How will these new skills and knowledge be:
  - o applied in the candidate's current or future role within your entity and,
  - o shared within the candidate's team or entity?
- What immediate or long-term benefits do you anticipate for your team or entity from the candidate's participation in the PtP program?
