Good afternoon \$22

I would first like to thank you and your team for your assistance and involvement in discussions we have been undertaking to inform our future fleet decisions.

As you are aware the next phase of our assessment will involve among other things testing selected vehicles at the TISC driver training facility and will include testing vehicle functions under normal driving conditions on a closed track and assessment of the physical specifications against COMCAR s operational requirements at the ACT COMCAR Depot and on the roads around Canberra. This will take place next week from Monday 26 September through to Friday 30 September.

In correspondence to manufacturers following initial meetings we notified them of this proposed next phase of assessment and asked if they could make selected models available to COMCAR for testing on these dates and I would appreciate SG Fleet assistance to coordinate this process.

The vehicles COMCAR is seeking to have available for the week of 26 September includes

- BMW iX3 and iX xDrive40
- Genesis GV60 and GV70
- Hyundai IONIQ 5
- KIA EV6 Polestar 2

I propose that a handover of vehicles from SG Fleet to COMCAR could occur on Monday 26 September and COMCAR would return the vehicles to SG Fleet by Friday 30 Septe

Some manufacturers also offered representatives that could be available to attend the assessment day at TISC on 28 September to address any technical questions. Whilst this offer is appreciated COMCAR would prefer instead that contact details are provided for a representative whom we could get in touch with should there be any questions.
