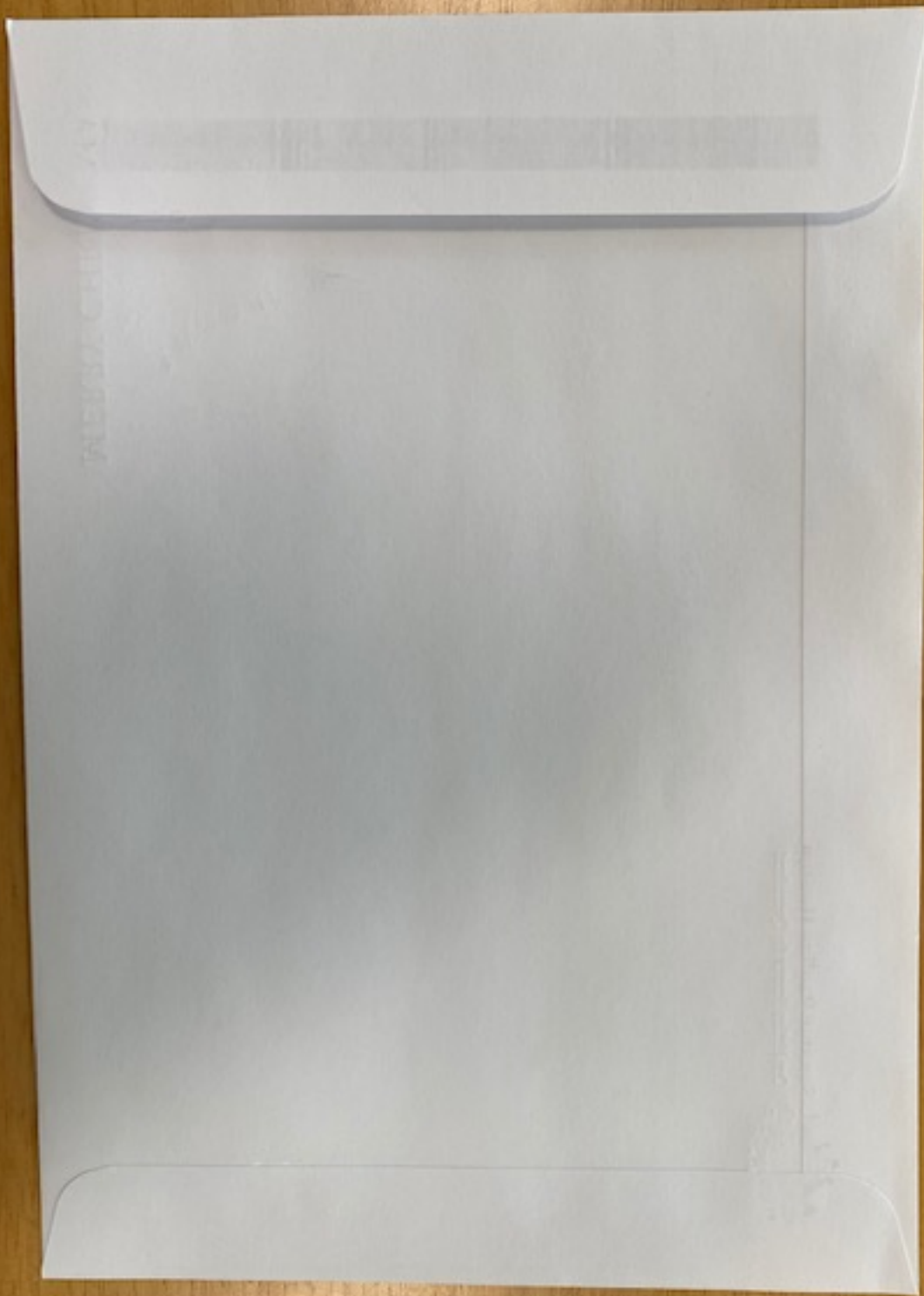

## YOUR ONE NATION TEAM

The Australian Parliament recently made a major decision about Queensland's economic future.

The Federal Labor Government and the Greens have struck a deal to make changes to the 'safeguard mechanism' in the climate legislation. The Labor/Greens plan is for 'NetZero' carbon emissions by 2030. These policies were first implemented by the Liberal/National Government 2016.



What does 'NetZero' mean? The Federal Government has based its climate policies on targets enforced by the U.N. While Australia accounts for just over 1% of all global emissions,<sup>1</sup> other countries like China and India are increasing their carbon output.

Put simply, companies or projects that emit more than 100 thousand tonnes of carbon dioxide every year are captured by the 'safeguard mechanism'.<sup>2</sup>



What does this mean? The Federal Government will use the legislation to stop many new mining projects in Central Queensland. Greens Leader Adam Bandt told ABC news that his party would spend the rest of the term fighting to shut down any new projects that come before the government<sup>3</sup> using this legislation. The mine shutdowns have already started, with the Federal Environment Minister refusing to approve a mine northwest of Rockhampton.<sup>4</sup>

During a media interview, Labor Minister Bill Shorten would not confirm or deny if Labor's climate plans would lead to electricity prices increasing.<sup>5</sup> Queenslanders have lost many jobs to high power prices, and these policies are taking food off our tables to pay for inner city elites.



What is One Nation doing? Your One Nation Senators voted against the 'safeguard' legislation because Queensland families are struggling enough.<sup>6</sup> We are fighting every day for sensible policies in parliament that will bring power prices down.

Using their legislative power over Labor, the Greens want to make deeper and harsher cuts to Australia's carbon emissions.



What does this mean? The Greens have proposed closing Queensland mines, which would result in the loss of hundreds of thousands of local jobs,<sup>3</sup> throwing our State into darkness and creating mass unemployment. One Nation will always fight in parliament against the Greens' devastating plans.

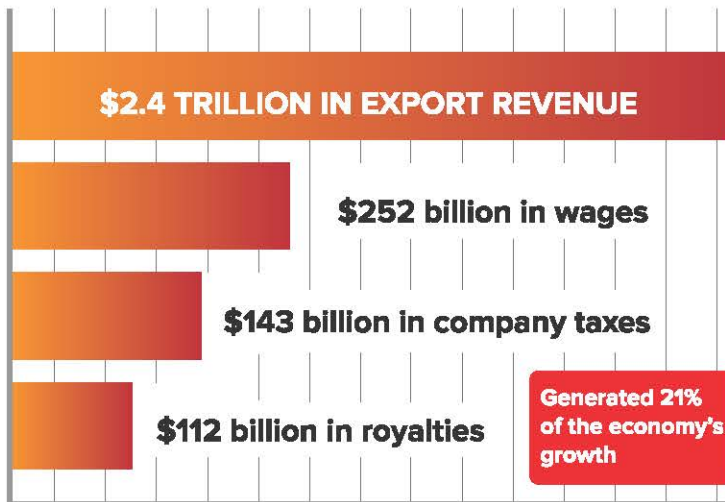

# YOUR ONE NATION TEAM

The federal Government’s budget was handed down on 10 May and there are some serious issues that need to be discussed about its impact on the average Australian household. Government debt is a direct driver of the country’s inflation and interest rate crisis.

Although government debt remains the greatest concern for most Australians, the greatest pinch people will feel from the budget is the mean-spirited removal of the middle and low income tax offset, which will mean hard-working Australians are about to be hit hard at tax time (1).



With government debt now causing higher interest rates for Australians, this on-average \$29 tax increase from the federal government is something worth fighting against. To slug families with higher taxes when they are struggling is the worst kind of economic thuggery.

Government debt is ballooning – from 4.7% of GDP in 2008 to 42.5% of GDP in 2021 (2) which is contributing to mortgage rate increases. The federal Labor Party has not produced a surplus in government for more than three decades. They have claimed this budget will have a small surplus; however, the Treasurer has acknowledged in budget papers this is partly off the back of the huge explosion in immigration levels and royalties from a mining industry they have vowed to destroy.



One Nation is opposed to the federal Government using immigration to prop up a budget bottom line because higher immigration means higher rents and mortgage repayments for Australians (3). We advocate for an expansion in the mining sector to pay for local schools, hospitals, police and infrastructure. In fact, Labor’s thin budget surplus comes off the back of an ‘increase in revenue courtesy of high commodity prices, high employment, high immigration, high corporate taxes, high taxes from higher wages, and high inflation’ (4).

For many years, the way Australian governments have increased debt is through the printing of money (5). It’s concerning a few so-called ‘economists’ and ‘journalists’ promote the pseudo-economics that there is no need to worry about debt as the Australian Government, “because it can effectively print its own money.” This is called Modern Monetary Theory or MMT. Printing money is doomed to failure. Every historic example has shown that printing money leads to hyperinflation.



The printing of money to pay for government expenses is dangerous, reckless, and counter-productive to a healthy economy. Debt hurts private citizens by ‘crowding out’ productive investment and jobs along with further inflating the costs of doing business and living. What is worse, printing money makes people less wealthy, as the value of the money they have saved has less value, especially if they have kept assets in cash (6).

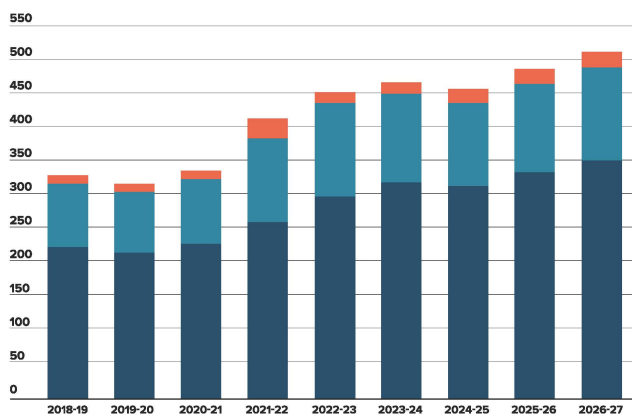


If interest rates were to increase at the rate they are, Australia's interest bill on debt would be \$64.1 billion in 2030-31 alone.

## Income tax receipts (\$bn)



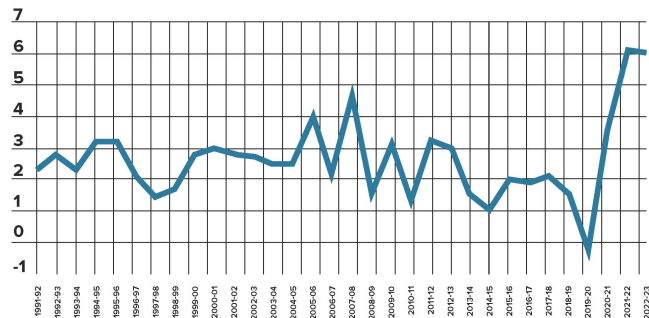

Inflation is out of control. Leading economists have said this budget will only increase the pressure on Australian families as it is likely prices will rise further. The Prime Minister has refused to rule out any additional interest rate increases (2).



Most disappointing in the budget is the lack of funding for vital infrastructure spending. Instead, the Treasurer has announced a 3-month review into infrastructure spending. Much of what has

been announced may be scrapped. It is highly likely that Queenslanders will miss out if infrastructure spending is cut for our state (3).
