I am writing to you regarding the in-principle approval provided to you on 14 July 2022 to relocate your electorate office, pending approval of a fully costed proposal.

The Parliamentary Business Act 2017 (the Act) empowers the Special Minister of State to determine certain public resources to be provided to a Federal member. These resources include one electorate office (or more in certain cases) within a member's electorate, an additional office for Ministers, and the resources to fitout and operate these offices. These publicly funded resources must be used in accordance with members' obligations under the Act, including that they be used for the dominant purpose of conducting their parliamentary business and provide value for money.

I have considered the proposal as provided to me by the Department of Finance (Finance) for the property located at Ground Floor, 100 Brougham Street, Geelong. Finance has provided me with advice that the proposal represents value for money in providing an electorate office for Corio.

Considering the in-principle agreement provided and the advice I have received from Finance, within my capacity as Special Minister of State, I have agreed the establishment of your new electorate office at this address, with the current Corio electorate office becoming your Ministerial office.

Finance will enter into a lease for the new tenancy for a period of three years with two options to extend for a further three years each.

Finance and its property services provider, Ventia, will continue to liaise with your office regarding the fitout and relocation.
